## Indiana Workers' Compensation TTD

**Note:** Temporary Total Disability (TTD) is paid weekly and is based on 2/3 of the employee's average weekly wage (AWW) on the date of the injury. TTD payments are subject to a maximum which varies depending on the date of the injury. The minimum AWW is \$75.00.
